VII. Executive Board Reports

- A. ESA Amber Hagel There is a question about a climate survey at the high school. OT, PT, SLP would like to voice concerns and share ideas about contract language. Discussion followed. There was a question about additional funding for mental health counselors. Could some of the funding be used to put the new counseling plan for the district in place? Counselors are concerned that they have been asked to complete this plan with no additional time and/or funding. Mike and Amber will follow up on this issue. Caseloads for Special Education in general are incorrect. The numbers have been incorrect all year. The concern is that there is not adequate staffing and coverage is not equitable. Susan Letson also shares this concern. SLPs in particular are short staffed.

- **D. Specialists Jo Grunewald** A member asked about elementary specialists who have only 15 minutes of planning time on certain days. Discussion followed.

- **G. SPED Susan Letson** Finding time to test students is a concern. Discussion followed. The group shared what is happening at different buildings in the district. Members asked about the cutoff date for Assist Team meetings so that any necessary testing can be completed before the end of the year. Last year it was April 14. Mike will communicate with Bill Weinsheimer. Discussion followed about how some buildings continued with meetings and referrals and tested in the fall. There is also a concern about Sp. Ed paras being pulled for other duties. Another member is concerned about short notice for an administrator not attending an IEP meeting. A member had a question about the procedure for students who elope (run away) from a school building. Discussion followed.
